I agree to release/hold harmless The Spirit of Dance Studio, its staff, instructors, and volunteers from any and all liability for any injury or illness (including COVID-19) to the student caused by, or resulting from, the student's participation in any classes, recitals, or programs conducted by The Spirit of Dance Studio, whether or not such injury or damage was caused by the negligence of The Spirit of Dance Studio, its staff or instructors, or any other cause. I further agree not to sue The Spirit of Dance Studio, its staff or instructors, or volunteers for any injuries or illnesses resulting from the student's participation in any classes, programs or performances conducted by The Spirit of Dance Studio, whether or not such injury/illness or damage was caused by the negligence or any other cause. I am aware that I am releasing certain legal rights that I otherwise may have as a condition of the student's participation in the classes and programs conducted by The Spirit of Dance Studio. I have carefully read this release and waiver provisions and understand its contents.

COVID-19: I (the dancer) agree to not attend classes and quarantine in the case of testing positive to COVID-19, displaying any symptoms or after being exposed to someone with COVID-19 or the Delta Variant. I (parent) agree to update the studio should the status of my dancer's health change.

I hereby give The Spirit of Dance Studio the right to include on its website ([www.spiritofdancestudio.com](http://www.spiritofdancestudio.com)) or its FB or Instagram Business page any photos or video taken at the studio, performances or special events in which my child participates. I understand that full names will not be published to maintain the privacy and safety for students. Social Media Defamation of our studio, dancers and/or instructors is a means for termination from the studio. Class tuition/fees are non-refundable and will not be refunded to any dancer who is removed from our program. All Dance Competition Entry Fees are Due Prior to Registering for the competitions. Any dancer participating in competitions must make these payments prior to any entries sent in. Dance competition fees are non-refundable.

The Spirit of Dance Studio has the right to combine or cancel classes and/or programs at any time based on enrollment prior to a dance session starting.
